2010 SUMMARY ANNUAL REPORT of the IBEW LOCAL 76 RETIREMENT TRUST FUND

This is a summary of the annual report of the IBEW Local 76 Retirement Trust Fund, EIN #91-6243526, Plan No. 001, this report is for the year beginning January 1, 2010 and ending December 31, 2010. The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement:

Benefits under the Plan are provided by the Trust. Plan disbursements were \$4,082,739. These disbursements included \$293,394 in administrative and operating expenses and \$3,789,345 in benefits paid to participants and beneficiaries. Approximately 2,929 persons were participants in or beneficiaries of the Plan at the end of the plan year.

The value of Plan assets, after subtracting liabilities of the Plan, was \$94,386,719 as of December 31, 2010, compared to \$83,584,404 as of January 1, 2010. During the Plan Year the Plan experienced an increase in its net assets of \$10,802,315. This increase includes unrealized gains or losses in the value of Plan assets, which is the difference between the market value at the beginning of the year and market value at the end of the year for those investments held at the beginning of the year, and also, includes the difference between the cost of the investment and the market value at the end of the year for those assets purchased during this plan year. During the plan year, the Plan had revenue of \$14,885,054. This includes employer contributions, voluntary contributions, rollovers and amounts collected through attorneys of \$4,987,226. Earnings from fee discounts, interest, dividends and capital gains of \$1,552,833 combined with realized and unrealized appreciation of \$8,344,995 resulted in net investment returns of \$9,897,828.
