SUMMARY ANNUAL REPORT FOR RETIREMENT PLAN OF THE IBEW LOCAL 76 RETIREMENT TRUST

This is a summary of the annual report for the Retirement Plan of the IBEW Local 76 Retirement Trust (Employer Identification Number 91-6243526, Plan Number 001) for the plan year 1/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by investments. Plan expenses were \$7,491,908. These expenses included \$620,642 in administrative expenses and \$6,871,266 in benefits paid to participants and beneficiaries. A total of 3,130 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$221,268,565 as of the end of the plan year, compared to \$187,726,035 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$33,542,530. This change includes unrealized depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$41,034,438, including employer contributions of \$4,063,146, employee contributions of \$1,902,314, rollovers into the plan of \$87,794, investment income of \$34,962,588, and other income of \$18,596.
